2006 KCERA Strategic Planning Session



The KCERA Board of Retirement conducted its annual Strategic Planning Session at the Hilton Garden Inn on February 2, 2006. At the meeting, Trustees discussed several initiatives related to KCERA's future growth and direction.

Tom Iannucci, the meeting facilitator from Cortex Applied Research, Inc., began the meeting with an overview on investment basics and a review of the Board's governance structure and policies. Following was a discussion of the Board's self-evaluation for the 2005 calendar year. The results of the review were very positive, with very few board members noting any dissatisfaction. Many of the improvement opportunities noted by the Board were already in the process of being addressed. Also, the Communication Policy was revised to include a legislative platform and the creation of an Ad Hoc Legislative Committee. These changes will facilitate timely response to legislative matters which may arise throughout the year.

Executive Director Anne Holdren led the remainder of the session devoted to discussion of KCERA's proposed 2006/07 business plan. This section of the meeting focused on projects that are either underway or proposed for the next fiscal year. Some of the key projects and initiatives include:

- Development of Business Continuity and Disaster Recovery Plan
- Assessment of KCERA's operational space needs
- Assessment of Pension Benefit System
- Acquisition and installment of new Accounting Software
- Measurement of Member Satisfaction

Tom Iannucci has worked with the KCERA Board since 1999, when Cortex was hired to draft the Board's governance frame work. Iannucci has been highly complimentary of the Board's efforts over the years, noting that KCERA's governance program is "...one of the most progressive and sophisticated governance efforts among public funds in the nation."

FAQ's

Q. What happens to my contributions if I leave County employment without retiring?

A. You have several options for your contributions if you leave County service without retiring:

- **Refund** - You may take a refund of your contributions and interest. However, a word of caution - if you do not reinvest your balance in a tax-deferred account, you may incur large tax penalties. You can avoid penalties by transferring your refund directly to another tax-deferred account.
- **Deferred Retirement** - If you have at least five years of service credit, you may leave your contributions on deposit and choose to receive a deferred retirement once you have met other eligibility requirements.
- **Reciprocity** - If you are going to work for another public retirement system within six months of your termination from Kern County, you may leave your contributions on deposit and choose a reciprocal retirement.
- **On Deposit** - You may leave your contributions on deposit with KCERA, where they will continue to earn interest until you decide to request a refund.

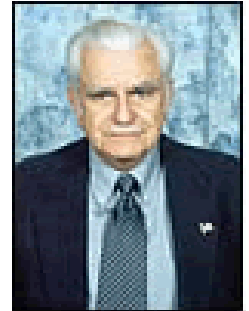
2006 Board Assignments

Retirees' Corner

Cost of Living Adjustment

On April 1, 2006 each retiree or beneficiary will become entitled to a Cost of Living Adjustment (COLA) increase. The increased COLA amount will appear on April 30, 2006 retirement warrants.

The COLA amount of 2.5 percent will be applied to annuity, pension, and previous COLA amounts. The COLA is not applied to any amounts paid from the Supplemental Retiree Benefit Reserve.

Income Verifications

Retirees and beneficiaries frequently request letters to verify their monthly retirement benefits. Verification letters are often needed when applying for loans or housing assistance. For faster service and to ensure timely receipt of income verification letters, always call or write the KCERA office directly. Sending requests to Northern Trust may result in a four to six week delay. KCERA staff are delighted to provide income verification letters and want to be sure you receive them as quickly as possible.

KCERA had a record setting year in 2005, with increases in new retirees and new active members. Staff processed 458 new retirees and 952 new members. By comparison in 2004, 190 members retired and 623 new members were enrolled - an increase of 240 percent and 153 percent respectively.

These increased numbers are directly attributable to the adoption of the 3 percent at 60 Retirement Tier for General members, which became effective January 1, 2005.
