8/12/25 to 9/2/25 by 5 p.m.	<p><b>Nomination Period</b> To pursue election to a seat on the Board of Retirement, qualified applicants* must submit required nomination documents. KCERA Board Election Information Packets are available online at: <a href="http://www.kcera.org/board-elections">www.kcera.org/board-elections</a>.</p> <p><i>A candidate may withdraw a declaration of candidacy no later than the last day of the Nomination Period (*or Extended Nomination Period, if applicable).</i></p>
9/3/25 to 9/9/25 by 5 p.m.	<p><b>Extended Nomination Period</b> If an incumbent trustee fails to meet filing requirements, any <i>other</i> qualified applicant can submit required nomination documents by this deadline to pursue election.</p>
	<p><b>Appointment in Lieu of Election</b> If only one member has met the filing requirements, no election shall be held, and that person will be appointed in lieu of election.</p> <p><i>For more detailed information regarding appointments in lieu of election, see KCERA's Elections Procedure Policy*: <a href="http://www.kcera.org/governance-policies">www.kcera.org/governance-policies</a>.</i></p>
9/16/25	<p><b>Candidate List</b> Candidate eligibility certified and official candidate list posted at KCERA and published online at: <a href="http://www.kcera.org/board-elections">www.kcera.org/board-elections</a>.</p>
9/17/25 to 10/7/25 by 5 p.m.	<p><b>Write-In Candidate Filing Period</b> A qualified applicant* may declare candidacy as a write-in candidate by meeting filing requirements.</p>
9/30/25	<p><b>Mail &amp; Email Official Ballots</b> Ballots mailed/emailed to eligible KCERA members*.</p>
10/21/25	<p><b>Election Day</b> Mail-in and electronic ballots must be received by 11:59 p.m.</p>
10/23/25 9 a.m.	<p><b>Counting of Ballots</b> Any person may observe the ballot count at the KCERA Office.</p>
10/28/25	<p><b>Certified Election Results</b> Election results certified to the Board of Retirement will be posted at KCERA and published online at <a href="http://www.kcera.org/board-elections">www.kcera.org/board-elections</a>.</p>
